

Conrad's Tire express & Total Car Care - Official Contest Rules

1. Eligibility

The Conrad's Score & Win 4 Tires Sweepstakes ("Sweepstakes") is open to Ohio residents 18 years of age or older, except employees and immediate family members (spouse, parents, siblings, and children) of Conrad's Tire Service, Inc., its affiliated and subsidiary entities (collectively "Conrad's Tire"), the Cleveland Guardians Baseball Company, LLC ("Cleveland Guardians"), and Major League Baseball and its Member Teams (all together herein after the "MLB Entities") and each of the MLB Entities' respective parents, subsidiaries, affiliates, directors, owners, employees, and agents (collectively "Sweepstakes Parties").

2. Sponsor

The sweepstakes is sponsored by Conrad's Tire Service, Inc., and the Cleveland Guardians Baseball Company, LLC.

3. Agreement to Official Rules

Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these official rules and fulfilling all other requirements set forth herein.

4. Sweepstakes Period

The Sweepstakes begins on March 26, 2026, at 12:00 a.m. Central Time (CT), and ends on September 27, 2026, at 11:50 p.m. Central Time (CT) ("Promotion Period"). Entries must be received by September 15, 2026, to be eligible for the drawings. Only one entry per person will be accepted. Entry must be completely filled out to be considered eligible.

To qualify, entries must be received during the Promotion Period. Any entries received thereafter shall be null and void, and ineligible for the Sweepstakes. Sweepstakes Parties are not responsible for late, incomplete, or misdirected entries.

5. How to Enter

There are two (2) methods of entry in the Sweepstakes as described below:

1. **Online Method of Entry:** To enter by the online form, visit econrads.com and follow the instructions to complete and submit the provided form on the site conradspromos.com
2. **Mail-In Method of Entry:** To enter by the online form, mail a self-addressed envelope with your name, address, city, state, zip code, daytime phone number, email address, and date of birth on a 3x5 card to Conrad's 4 Tire 4 Run Giveaway Inning, Progressive Field, 2401 Ontario St. Cleveland, OH 44115.

6. Prize

Each Prize includes four new Bridgestone tires up to \$800 value including Standard Installation and Tire fee. Winner is responsible for any additional amount over \$800 including sales tax.

Approximate retail value of four tires is \$800.

7. Winner Selection and Notification

The Winner will be notified by phone, email, or mail if they win. In the event the Winner cannot be contacted or declines the Prize, an alternate winner may be selected among remaining eligible entries.

One (1) drawing will be held for each Cleveland Guardians game during the Promotion Period to select a participant of the day (the "Participant") for the chance to win one grand prize that day ("Prize").

Prize will be awarded to the Sweepstakes of a given day if the Cleveland Guardians score four or more runs within the 1st, 2nd, 3rd, or 4th inning of a

Cleveland Guardians game that day (the Participant on such a day will be a "Winner").

A maximum of one Prize will be awarded per game during the Promotion Period (although for those games in which the Cleveland Guardians do not score four or more runs in one of the first four innings, there will be no Winner).

The four or more runs must be scored within one inning during an official game. Whether or not four or more runs are scored by the Cleveland Guardians in the designated innings of an official game will be based on the determination of the official scorer present at the Cleveland Guardians baseball game and the applicable Major League Baseball league office.
